## 3. Charis report Report:

- Brainstorm fundraising ideas for the school and bring forward during the next meeting. Must follow COVID-19 protocols.
- School lunches such as pizza and sub days are still on hold, waiting on Board approval.
- Since we are unable to hold a Christmas Concert this year, we will look into doing a Christmas message from each class and it can be posted on Guardian Angels Youtube channel.
- 4. **Treasurer's Report:** K.O'Donnell, copy of opening school budget provided. The cheque from Mr. Sub has come through (\$584) and we did deduct the classroom consumables from our budget which was \$1686.78 out of the budget of \$5000.00 this gives us a saving of \$3313.22 to put back into our total. Leaving us with roughly \$5,277.10 to support the school.
- **5. Parish Rep:** There are forms available online through the Guardian Angels Parish website for First Communion and Confirmation. The forms have also been sent home through the school with each child that will be receiving the Sacraments this year and they are due November 30th,2020.
- **6. OPACE:** There is a workshop on November 7th and 21st, titled "Parenting during a Pandemic".

November 11th, Human Trafficking Presentation it was sent in an e-mail. It is held from 7-8 p.m virtually.

## 7. Principal's Report:

- There was a student caregiver tool kit sent out with stay home protocols. The school follows direct actions from Peel Health.
- To date we have no cases in the school.
- There are 84 students returning from Virtual to Hybrid Learning out of 190. 106 students are still in virtual school.

- School enrollment is 448.
- In the Hybrid mode there are 20 children in a class maximum, it could be composed of 10 online students and 10 in class one day and 12 online students and 8 in class the next for example. There is flexibility.
- Teachers will do online attendance. You will only call into the school if your child
  is going to be away from both online and in-person learning for the day, in the
  Hybrid model.
- The school has sent \$1400 to the Terry Fox Foundation from our Terry Fox walk.
- October 9th, 2020 the school had a Thanksgiving mass streamed into class. It will
  continue to do so for Christmas, Easter and End of Year.
- Mrs.Makatore has set up a Virtual Rosary Apostolate that will happen last Thursday of every month.
- October 21st was Bus Driver Appreciation Day.
- Last year's Graduation was done virtually and we had hoped there would be some kind of ceremony but the school was unable to hold a ceremony in person.
   The school was instructed to hand out awards by October 30th. Unfortunately the green folders did not come in this year for the certificates.
- Halloween Spirit week was a success and the cohort dances were awesome! all followed COVID-19 protocols that were put in place. The school had themes, announcement games and the dance. The next Spirit week is November 16, "Bullying Awareness and Prevention Week". It is planned by student council with a virtual assembly presentation by former DP student, Giselle Gaylie.
- Remembrance Day virtual assembly will be on November 11th @11:00 am.
- Pastoral plan was submitted and is under review. It will be posted on the school website once it has been approved.
- SIT meeting will focus on setting and reviewing goals for this school year. It will be posted on the school website.
- New math curriculum. The school has no robots for coding, maybe we can invest
  in coding materials and allocate some funds to it. We will postpone till the next
  meeting.
